A signed Statement of Policies and Waiver of Liability, are required to be on file for enrollment at JandJ Performing Arts. Please read and sign the following: Statement of Policies and Wavier of Liability. We, as JandJ Performing Arts Instructors reserve the right to place the student in the appropriate class level. Enrollment in jazz only, as opposed to jazz and ballet, will affect the class your dancer is enrolled in, as those dancers taking ballet receive foundational training in technique and progress much faster. Placement is determined by three factors technique, execution, and showmanship all are expected to be equally mastered.

## MONTHLY TUITION AND LATE FEES

- Enrollment at JandJ is on a monthly basis. There will be no refunds, credits, or pro-rates for any classes dropped mid-month by the student. JandJ requires **30- day notice for any and all classes dropped.**
- Tuition is on a pre-paid basis only. Tuition is due before the 6<sup>th</sup> of each month and late after the 15<sup>th</sup> of the month. If tuition is late a \$15 late fee may apply
- JandJ does not charge extra for months with 5 weeks; nor charge less for months with 3 weeks. JandJ also does not charge extra for planned extra practices. JandJ does not give refunds, or pro-rates for classes missed due to illness or studio holidays. Students may take a make-up class for classes missed; Must be approved by director.
- Tuition may be paid by month or up to 10 months at a time by cash, check, or money order. Tuition may be paid by automatic withdrawal by credit card. Checks returned due to insufficient funds will be charged \$25 and all bank fees associated with the return

\*If students will not be able to perform for the recital in June proper notice before the first of May is necessary, no notice will result in full June tuition due. Full **balances are due prior to performances**, or your child may not be allowed to perform. Any payments may be worked out with prior notice.
